### UP FRONT – A Word from the Editor

I cannot emphasize enough the importance of officer elections. Clubs are both social organizations and (legally speaking) businesses. Any group of people, no matter their purpose for existing, needs leadership to maintain a healthy social dynamic. Otherwise, the group loses focus and direction.

For several years, the club has struggled to find officers to provide that needed leadership. At times, we have had to waive some of the requirements of our own by-laws in order to fill a vital office. This should not be.

I know not everyone is capable of serving. Ten years ago, I had to resign as TRO Activities Chair because a lack of transportation prevented me from performing my duties. But just sending in your dues once a year to keep the repeaters running is no longer enough. When members fail to take an active interest in their club, then the club ceases to be interesting. If that trend continues, then the club ceases to be.

### Mark Conklin N7XYO - President

I earned my amateur radio license in 1992; I currently hold a General class license. I am a long-term member of the Tulsa Repeater Organization and a member of the Tulsa Amateur Radio Club. I am also a lifetime ARRL member.

I have been the ARRL Oklahoma Section Emergency Coordinator (ARES-OK) for several years and also served as an ARRL Public Information Officer, and as the ARRL Oklahoma Section Public Information Coordinator. In the past, I served three terms as TRO president, and several years as the club's PR Committee chairman. I am also active in our community as a SKYWARN storm spotter and occasionally storm chase for a local TV station. As needed, I have assisted the Tulsa Area Emergency Management Agency with communications support.

My wife, Lynn Adair, and I (and our spotted dogs) live in northern Okmulgee County, where I help as the Communications Officer for Okmulgee County Emergency Management. I am also a reserve deputy sheriff assisting with operations, planning and training. On weekdays (and a few Saturdays) you can find me at Stow's Office Furniture in Tulsa, where I am the assistant store manager.

### Paul Young, KE5EHM - Vice President

I got started in CB radio in 1975 at age 20, did volunteer work with the Salvation Army Communications club, and did this for 5 years. I worked at Safeway and Homeland for 23 years started out as a sacker then to checker and on to Produce manger for a year or so. Had to retire from Safeway in 1995 because of back problems. High school friend and ham got me thinking about getting my ham ticket. I went to a class and studied and took my test March 2005 at the Green Country Hamfest and got my ticket on the 29<sup>th</sup>. I joined TRO and started helping on their events. # Steve Miller, AA5V - Treasurer

I have been Treasurer of the TRO for seven years in the past and it is my fourth office held in TRO since becoming a member in 1978. I have been the Site Chairman of the 146.94 MHz repeater since 1981. My interest in amateur radio began with earning the Amateur Extra Class license and Commercial Radiotelephone license in 1978. I have been a member of ARRL since April 1977.

Additional membership activities include my participation in the planning committee for Green Country Hamfest, Inc., VE test examiner, webmaster for TRO and Green Country and as an active member in the Skywarn Group. My occupation is a Lead Programmer Analyst for Tulsa County.

## Merlin Griffin, WB5OSM - Trustee

I was first licensed as WN5EMG in 1971 back when Novices were only allowed CW operation on 80, 40, and 15 meters. crystal controlled and power limit of 75 Watts DC Input. I mainly operated on 40 meter CW, and the Xtals I chose, I learned there were shortwave broadcasters at night on two of the three frequencies. It was my 75 watts against their ¼ megawatt.

I now hold the Extra Class license and as many of you know. I am a highly experienced ARRL accredited Volunteer Examiner, one of the most experienced in the U. S. I have participated in somewhere around 250 test sessions.

I am a past president of the TRO. I also serve as president of Green Country Hamfest, Inc. I am vice president and frequency coordinator for Oklahoma Repeater Society, Inc. We coordinate repeater frequencies in the state of Oklahoma and work with coordinators in the surrounding states to minimize interference across state lines. I serve as net control operator for the Tulsa Skywarn operation, which I have been involved in that for many years. I think some of the other Skywarn NCO refer to me as NCO Emeritus. I also serve TRO as the engineering site chairman for the 146.88 repeater.

I have been employed by the City of Tulsa for 35 years, currently doing database administration and computer support for the Public Works Department's Quality Assurance Laboratory. I have expertise in both fields, analytical chemistry and computer science.

I reside in Owasso and have been an Owassoan since before it was cool. I am married to Lynda KE5VYN and have two beautiful grandchildren living with us most of the time: Kevyn, ten, and Lexie, who just turned nine. You have seen the bumper sticker, "If I knew grandchildren were so much fun I would have had them first." I pulled that off! ### Douglas Lee, KC5ZQM

I haven't yet decided, but I am considering the office of Secretary. With that in mind, I offer my ham radio testimony, written in November 2013:

I should have become a ham radio operator back in the last half of the 1970's. I was in the communications section of the Oklahoma Army National Guard unit in Sapulpa then, and I was also part of the national CB radio craze. Many of the CB operators in Sapulpa looked up to hams, some wanted to become hams, and a few did. I wanted to, but never followed up on that desire, until about 20 years later.

For most of my life, I have been interested in science, especially meteorology. My interest in weather kept drawing my attention, especially when storms passed through the area. So, in late 1993, I decided to pursue a career as research meteorologist. My first step was to obtain an associate degree in mathematics from Tulsa Community College before moving on to Oklahoma University. My interest in weather eventually lead me into ham radio.

While I was studying at TCC, storm chasing began to become popular. I knew that many storm chasers and spotters were hams, and they used ham radio to communicate with each other and with the National Weather Service. I had also developed an idea for a research project that could be managed by the use of spotters and ham radio. Now, I had a reason to go ahead and become a ham!

In early January, 1997, just after receiving my math degree, I called the NWS office in Tulsa to find out when and where they would have storm spotter training sessions that year. They told me about a session later that month at the West Tulsa Regional Library, and sponsored by the Tulsa Amateur Radio Club.

After the session, I noticed several people going up to one man in particular to talk to him. I thought he must be someone important in the club, and someone to talk to about becoming a ham. Well, that man was Vince Moore, N5RFW, and he was the Public Service Liaison for the club. He is now a Silent Key.

When I introduced myself to him and told him that I wanted to become a ham, he told me about a book, "Now You're Talking," and he said that it would tell me in easy-to-understand language everything I needed to know to pass the test for the entry-level Technician class license. Moments later, I checked the stacks at the library and found an older edition of that book. I checked it out and read it.

But I needed more study before taking the test. Then, Radio Shack offered a current edition on sale. I bought one and read it a couple of times before taking – and passing – the test at the Green Country Hamfest held in March at the Convention Center in downtown Tulsa.

After that, I called the toll-free number at ARRL headquarters for over a week so they could check the FCC database for me. Finally, on March 25, they told me I now had the call sign of KC5ZQM.

Since then, as a ham, I have been involved in storm spotting, emergency and public service communications, foxhunting, balloon tracking, and I have built antennas of my own design.

Nowdays, my major interest in ham radio is public service. I am not able to do as much as I would like, but I do as much as I can. I also serve the Tulsa ham radio community itself by editing and publishing the TRO Signal Bulletin, a weekly text-only bulletin focused on ham radio events and activities in the Tulsa area.
