# TULSA COUNTY ARES PLANS FOR SIMULATED EMERGENCY TEST (SET): The ARES Tulsa County Simulated Emergency Test (SET) is planned for Saturday, Oct 5.

The SET is an exercise to train Amateur Radio operators how to inter-operate between ARES teams and served agencies.

# We anticipate participation from the following:

- ●Tulsa Area Emergency Management Agency (TAEMA). Will function as Net Control.
- Medical Emergency Response Center (MERC). We plan to conduct a hospital net during the SET.
- Other local agencies.
- ●VHF/UHF FM analog, HF voice, and Digital via Winlink

# How can you prepare for the SET?

- ●Complete the NIMS FEMA training (ICS 100, 200, 700, 800).
- Brush up on ARRL NTS message handling techniques (for HF traffic).
- ●Training resources can be found at <u>www.aresok.org</u>.
- Prepare your go bags.
- •Prepare to use emergency power for the duration of the SET (up to 3 hours).
- •If you know or plan to be working in a served agency make certain you wear the ARES approved deployment vest. We want to be very visible.
